- 1. This appoints you, per reference (a), to inquire into facts and circumstances surrounding the wearing of an unauthorized patch by aircrew of HSC-25 on their uniform during a Presidential visit on 28 May 2019.
- 2. Investigate all the facts and circumstances surrounding an unauthorized wearing of a patch on the flightsuit uniform which was in the likeness of President Trump that said "Make Aircrew Great Again" during a Presidential visit on 28 May 2019 by HSC-25 aircrewmen violating DODD Instruction 1344.1. Report any fault, neglect, or responsibility, and recommend appropriate administrative or disciplinary action. Report your findings of fact, opinions, and recommendations in letter form by 28 June 2019, unless an extension of time is granted. If you have not previously done so, read Chapter II of reference (a) in its entirety before beginning your investigation.
- 3. You may seek legal advice from CDR (b) (6) , JAGC, USN, CPR 11, during the course of your investigation.

1. This appoints you, per reference (a), to inquire into facts and circumstances surrounding the wearing of an unauthorized patch by aircrew of HSC-25 on their uniform during a Presidential visit on 28 May 2019.

2. Investigate all the facts and circumstances surrounding an unauthorized wearing of a patch on the flightsuit uniform which was in the likeness of President Trump that said "Make Aircrew Great Again" during a Presidential visit on 28 May 2019 by HSC-25 aircrewmen violating DODD Instruction 1344.1. Report any fault, neglect, or responsibility, and recommend appropriate administrative or disciplinary action. Report your findings of fact, opinions, and recommendations in letter form by 28 June 2019, unless an extension of time is granted. If you have not previously done so, read Chapter II of reference (a) in its entirety before beginning your investigation.

3. You may seek legal advice from CDR (b) (6) , JAGC, USN, CPR 11, during the course of your investigation.



RESULTS OF INTERVIEW OF LCDR (b) (6) OFFICER IN CHARGE, HSC-25 DET SIX

The statement that appears on this page (and the following 2 pages, all of which are signed by me) is made freely and voluntarily by me, and without any promises or threats having been made to me or pressure or coercion of any kind having been used against me.



- 1. LCDR (b) (6) USN Officer in Charge (OIC) HSC-25 Detachment Six was read his UCMJ Article 31b rights. Rights were acknowledged and waived.
- LCDR (b) (6) checked into HSC-25 on 30 Oct 2018. By his best recollection, he witnessed the "Make Aircrew Great Again" (MAGA) patch during his first week in the command. The MAGA patch was being worn by aircrew in the presence of Commanding Officer, CDR Frank M. Loforti, USN HSC-25 and Executive Officer, CDR (b) (6)
   USN HSC-25. The approval was verbal within the command and was not witnessed first-hand by the LCDR (b) (6)
- 3. LCDR (b) (6) believes the patch was created by AWS1 (b) (6) USN sometime between 2016 and 2017 in Guam, while he was a Sailor assigned to HSC-25. The specific manufacturer is unknown, but believed to be located in Guam. LCDR (b) (6) had no knowledge behind the history or verbal command policy until it was provided by LT (b) (6) USN HSC-25 Detachment Six Operations Officer (OPS) on 28 May 2019. When first introduced at the squadron in 2016/2017 (exact date unknown) Commanding Officer, CDR William G. Eastham, USN and Executive Officer, CDR Loforti discussed the MAGA patch approval on flight suits within squadron spaces at a command All Officers Meeting (AOM).
- 4. According to the LCDR (b) (6) , the Detachment leadership was unaware of the POTUS visit to USS WASP prior to their departure and transit to NAF Atsugi Japan on

- 03 May 2019. At no time does LCDR (b) (6) remember witnessing the patch on any of the detachment aircrew, during their pre-deployment preparations in Japan.
- 5. The early crew departed Atsugi 18 May 2019. LCDR (b) (6) along with five other pilots, six aircrew and cargo flew aboard WASP on the 22 May 2019 and LCDR (b) (6) email account was operational 23 May 2019 at 1600.
- 6. LCDR (b) (6) did not brief the POTUS visit information either by delegation or directly, because he believed that no one from his Detachment would be attending the POTUS event. It was the Detachment's understanding from the 5050 that 500 WASP Sailors had already been pre-selected and the Detachment personnel were not on the list. LCDR (b) (6) was aware of the Plan of the Day (POD) note pertaining to DOD Directive 1344.1. LCDR (b) (6) was emailed the electronic 5050 delineating the Navy Working Uniform Type III with Eight Point Cover as the prescribed uniform for the POTUS event. He did not brief this information either by delegation or directly because he believed that no one from his Detachment would be attending the POTUS event. LCDR (b) (6) does not recall receiving or reading the all hands email sent by Staff Judge Advocate, COMPHIBRON 11, CDR (b) (6) , JAGC, USN on 22 May 2019, and he has no knowledge of the information within the email ever being provided to the detachment Sailors.
- 7. At approximately 1400 on 28 May 2019, LTJG (b) (6), USN Detachment Division Officer (DIVO) was the first person to inform LCDR (b) (6) that some of their aircrew were at the POTUS speech, had been wearing the MAGA patch, and were told to remove the patch by an unknown CDR. LCDR (b) (6) has no knowledge of their actions once told to remove the patch. At approximately 1415, LT (b) (6) , USN Assistant Officer in Charge (AOIC) informed LCDR (b) (6) that all nine aircrew had attended the POTUS speech and were able to get a signed MAGA patch. while POTUS interacted with the crowd. LCDR (b) (6) instructed LT (b) (6) have all nine aircrew involved report to his stateroom because he was unaware of their POTUS speech attendance while wearing the MAGA patch. The crewmen who reported to LCDR (b) (6) stateroom were as follows: AWS1 (b) (6) USN; AWS1 , USN; AWS2 (b) (6) , USN; AWS2 (b) (6) USN; (b) (6) , USN; AWS2 (b) (6) , USN; AWS2 (b) (6) AWS2 (b) (6) USN: AWS3 (b) (6) , USN; AWS3 (b) (6) USN, and Detachment Maintenance Senior Chief (b) (6) , all of the aircrew were unaware of the POD note or DOD Directive 1344.1. LCDR (b) (6) confiscated all MAGA patches from AWS1 (b) (6) later in the afternoon of 28 May 2019 and was in possession of all known MAGA patches at the time of the interview.

8. Later in the afternoon of 28 May 2019, when the MAGA patches were collected, AWS1 (b) (6) informed the OIC that the aircrew attendance was his idea. It was also his idea to pass out patches to the aircrew prior to entering the hangar bay.

RESULTS OF INTERVIEW OF LT (b) (6) USN ASSISTANT OFFICER IN CHARGE, HSC25 DET SIX

The statement that appears on this page (and the following 01 page, all of which are signed by me) is made freely and voluntarily by me, and without any promises or threats having been made to me or pressure or coercion of any kind having been used against me.



- 1. LT (b) (6) USN HSC-25 Detachment Six Assistant Officer in Charge (AOIC) was read his UCMJ Article 31b rights. Rights were acknowledged and waived.
- 2. LT (b) (6) checked into HSC-25 in April 2017. Upon check-in, the Commanding Officer was CDR Ed Weiler, USN HSC-25 and the Executive Officer was CDR Will Eastham, USN HSC-25. By his best recollection he had witnessed the "Make Aircrew Great Again" (MAGA) patch after his first six months in the command. The MAGA patch was being worn and sold by aircrew with the perception of Commanding Officer approval, but no formal flight suit guidance existed.
- 3. LT (b) (6) believed the patch was created by AWS1 (b) (6) USN HSC-25 sometime between 2016 and 2017 in Guam while he was assigned to HSC-25 from Nov 2014 thru Mar 2019. LT (b) (6) had no knowledge of the MAGA patch history or verbal command policy and was unaware of the manufacturer. LT (b) (6) believes that the current squadron's Commanding Officer, CDR Frank Loforti, USN HSC-25 and Executive Officer, CDR (b) (6) USN HSC-25 had not restricted the wearing of the MAGA patch or issued formal guidance.
- 4. According to LT (b) (6) the performance of the POTUS visit to USS WASP prior to their departure and transit to NAF Atsugi Japan on 03 May 2019. At no time did LT (b) (6) remember witnessing the patch on any of the Detachment aircrew during their pre-deployment preparations in Japan between the dates of 03 May 2019 and 18 May 2019.

- 5. LT (b) (6) and the Detachment early crew checked onboard WASP 18 May 2019 and his email account was active on 21 May 2019 (exact time unknown).
- 6. LT (b) (6) was not aware that any of HSC-25 Sailors would be attending the POTUS event. It was the Detachment's understanding that 500 WASP Sailors had already been pre-selected and his Detachment personnel were not on the list. LT (b) (6) was aware of the Plan of the Day (POD) note pertaining to DOD Directive 1344.1. He was not aware of the WASP 5050 or the all hands email sent by CDR (b) (6) and did not brief POTUS visit information to the Detachment by delegation or directly, because he believed none of their Sailors would be attending the event.
- 7. At approximately 1300 on 28 May 2019, AWS1 (b) (6) USN HSC-25 informed LT (b) (6) that all nine aircrew had attended the POTUS event and had MAGA patches signed by POTUS during his interaction with the crowd. AWS1 (b) (6) also informed LT (b) (6) that an unknown CDR had informed them that they should not be wearing the MAGA patch and they should remove it. The exact reaction by Detachment aircrew speaking to the unknown CDR was unknown to LT (b) (6).
- 8. At approximately 1330, LT (b) (6) went to LCDR (b) (6) , USN Officer in Charge (OIC) HSC-25 Detachment Six stateroom. LTJG (b) (6) , USN HSC-25 Detachment Division Officer (DIVO) were already in LCDR (b) (6) stateroom informing him that nine of their aircrew were at the ceremony wearing the MAGA patch. LT (b) (6) and LTJG (b) (6) informed LCDR (b) (6) that the aircrew were told to remove the patches by an unknown CDR. LCDR (b) (6) instructed LT (b) (6) have all aircrew involved and the DLCPO report to his stateroom. The crewmen in , USN; AWS1 (b) (6) attendance were as follows: AWS1 (b) (6) . USN: AWS2 (b) (6) , USN; AWS3 (b) (6) , USN; AWS3 (b) (6) USN, and Detachment Maintenance Senior Chief (b) (6) , USN. When asked by LCDR (b) (6) and all of the aircrew were unaware of the POD note or DOD Directive 1344.1. LCDR (b) (6) confiscated all MAGA patches the evening of 28 May 2019 and is currently in possession of all known MAGA patches.

RESULTS OF INTERVIEW OF LT (b) (6) USN OPERATIONS OFFICER, HSC25 DET SIX

The statement that appears on this page (and the following 01 page, all of which are signed by me) is made freely and voluntarily by me, and without any promises or threats having been made to me or pressure or coercion of any kind having been used against me.



- 1. LT (b) (6) USN HSC-25 Detachment Six Operations Officer (OPS) was read his UCMJ Article 31b rights. Rights were acknowledged and waived.
- 2. LT (b) (6) checked into HSC-25 in June 2017. Upon check-in, the Commanding Officer was CDR Edward Weiler, USN HSC-25 and the Executive Officer was CDR Will Eastham, USN HSC-25. By his best recollection he first witnessed the "Make Aircrew Great Again" (MAGA) patch between Jun 2017 and Dec 2017. The MAGA patch was being worn and sold by aircrew with the perception of the Commanding Officer's approval, but no formal flight suit guidance existed. Sometime between Jan 2018 and Apr 2018 the command held an All Officers Meeting (AOM) that LT (b) (6) attended. During this AOM the new Commanding Officer, CDR Eastham discussed the MAGA patch, granted his approval and stated that the patch was in good taste.
- 3. LT (b) (6) has no knowledge of the patch history, creator or the name of the manufacturer but believes it was created in Japan. LT (b) (6) believes that the current squadrons Commanding Officer, CDR Frank Loforti, USN HSC-25 and Executive Officer, CDR (b) (6) , USN HSC-25 allow the MAGA patch to be worn on flight suits within squadron spaces.
- 4. According to LT (b) (6), LCDR (b) (6) USN HSC-25 Detachment Six Officer in Charge (OIC) and LT (b) (6) USN Assistant Officer in Charge (AOIC) was aware of the POTUS visit to the Japan AOR prior to their departure and transit to NAF Atsugi Japan on 03 May 2019.

- 5. LT (b) (6) doesn't remember witnessing the patch on any of the Detachment aircrew during their pre-deployment preparations in Japan between the dates of 03 May 2019 and 18 May 2019.
- 6. LT (b) (6) checked onboard WASP 22 May 2019 and his email account was active on 23 May 2019 (exact time unknown).
- 7. LT (b) (6) was not aware that any of HSC-25 Sailors would be attending the POTUS event. On 27 May 2019 at 1800, LT (b) (6) was told by LCDR (b) (6) that HSC-25 Detachment personnel would not be attending POTUS speech. LT (b) (6) was not aware of the Plan of the Day (POD) note pertaining to DOD Directive 1344.1, WASP 5050, the all hands email sent by CPR11 SJA, CDR (b) (6) , JAGC, USN, or the NWU Type III uniform requirements.
- 8. At approximately 1200 on 28 May 2019, LT (b) (6) was informed by LT (b) (6) HSC-25 Detachment Six that HSC-25 aircrew had attended the POTUS speech wearing their MAGA patches.

The foregoing statement is true and correct to the best of my information and belief.

- 1. LT (b) (6) USN HSC-25 Detachment Six was read his UCMJ Article 31b rights. Rights were acknowledged and waived.
- 2. LT (b) (6) checked into HSC-25 on 26 April 2019 under Temporary Assigned Duty (TAD) orders from HSC-21. LT (b) (6) was within the HSC-25 spaces for seven days and witnessed the "Make Aircrew Great Again" (MAGA) patch within the squadron. LT (b) (6) believed the Commanding Officer, CDR Frank Loforti, USN HSC-25 and Executive Officer, CDR (b) (6) USN HSC-25 allowed the MAGA patch to be worn on flight suits within squadron spaces.
- 3. Lt (b) (6) checked aboard USS WASP on 18 May 2019 and his email account was active on 24 May 2019 (exact time unknown).
- 4. LT (b) (6) was not aware of the Plan of the Day (POD) note pertaining to DOD Directive 1344.1 or the all hands email sent by CPR11 SJA, CDR (b) (6) , JAGC, USN. LT (b) (6) was aware and had read the POTUS event WASP 5050 and the NWU Type III uniform requirements.
- 5. LT (b) (6) did not brief the POTUS event information either by delegation or directly, because he believed that no one from the Detachment would be attending the POTUS event.
- 6. On 28 May 2019 at 0530, while working in Wardroom Lounge one on USS WASP LT

  (b) (6) is informed by the Command Duty Officer LCDR (b) (6) USN USS

WASP Maintenance Officer, that HSC-25 Sailors could attend the POTUS speech. LCDR (b) (6) informed LT (b) (6) that the HSC-25 Sailors would be required to wear the Naval Working Uniform (NWU) type III uniform with eight point cover and muster for screening in the upper vehicle storage area at 0630.

7. At 0545, LT (b) (6) calls the HSC-25 maintenance space and passed the information (LT (b) (6) is not aware of who answered the phone) that HSC-25 Sailors could attend the event as long as they wore the NWU type III uniform with eight point cover and mustered for screening in the upper vehicle storage area at 0630.

- 1. LTJG (b) (6) USN HSC-25 Detachment Six Division Officer (DIVO) was read his UCMJ Article 31b rights. Rights were acknowledged and waived.
- LTJG (b) (6) checked into HSC-25 on 18 Feb 2019. Upon check-in, the Commanding Officer was CDR Frank Loforti, USN HSC-25 and the Executive Officer was CDR (b) (6) , USN HSC-25. LTJG (b) (6) does not remember seeing the "Make Aircrew Great Again" (MAGA) patch in Guam.
- 3. LTJG (b) (6) had no knowledge of the MAGA patch history or verbal command policy and was unaware of the manufacturer.
- 4. According to LTJG (b) (6), Detachment leadership was unaware of the POTUS visit to USS WASP prior to their departure and transit to NAF Atsugi Japan on 03 May 2019. LTJG (b) (6) does not remember witnessing the patch on any of the Detachment aircrew during their pre-deployment preparations in Japan between the dates of 03 May 2019 and 18 May 2019.
- 5. LTJG (b) (6) checked onboard WASP 22 May 2019 and his email account was active on 23 May 2019 (exact time unknown). First Log-in was 24 May 2019.
- 6. LTJG (b) (6) was not aware that any of HSC-25 Sailors would be attending the POTUS event. It was the Detachment's understanding that 500 WASP Sailors had already been pre-selected and his Detachment personnel were not on the list. LTJG (b) (6) was aware

of the Plan of the Day (POD) note pertaining to DOD Directive 1344.1. He was not aware of the WASP 5050 or the all hands email sent by CDR (b) (6) and did not brief POTUS visit information to the Detachment by delegation or directly, because he believed none of their Sailors would be attending the event.

- 7. At approximately 1245 on 28 May 2019 AWS2 (b) (6) USN HSC-25 informs LTJG (b) (6) of the MAGA patch signed by POTUS. Shortly after, AWS1 (b) (6) USN HSC-25 informed LTJG (b) (6) that the aircrew had attended the POTUS event and that an unknown CDR had informed them that they should not be wearing the MAGA patch and they should remove it. All aircrew removed the MAGA patch after being instructed to do so.
- 8. At approximately 1300, LTJG (b) (6) went to LCDR (b) (6) USN Officer in Charge (OIC) HSC-25 Detachment Six stateroom to inform him that their aircrew were at the ceremony wearing the MAGA patch. LT (b) (6) , USN HSC-25 Detachment Six Assistant Officer in Charge (AOIC) arrived at LCDR (b) (6) stateroom at approximately 1315. Both LT (b) (6) and LT (b) (6) inform LCDR (b) (6) that the aircrew were told to remove the patches by an unknown CDR. LCDR (b) (6) instructs LT (b) (6) to have all aircrew involved and the DLCPO report to his stateroom. AT 1400 all aircrew muster in LCDR (b) (6) stateroom. The crewmen in attendance were as follows: AWS1 (b) (6) . USN; AWS1 (b) (6) , USN; AWS2 (b) (6) , USN; AWS3 (b) (6) , USN; AWS3 (b) (6) , USN, and Detachment Maintenance , USN. When asked by LCDR (b) (6), all of the Senior Chief (b) (6) aircrew were unaware of the POD note or DOD Directive 1344.1. LCDR (b) (6) confiscated all MAGA patches the evening of 28 May 2019 and is currently in possession of all known MAGA patches.

The foregoing statement is true and correct to the best of my information and belief.

The statement that appears on this page is made freely and voluntarily by me, and without any promises or threats having been made to me or pressure or coercion of any kind having been used against me.



- ATCS (b) (6)
   USN Detachment Leading Chief Petty Officer (DLCPO)
   HSC-25 Detachment Six was read his UCMJ Article 31b rights. Rights were acknowledged and waived.
- 2. ATCS (b) (6) checked into HSC-25 July 18<sup>th</sup>, 2018. Upon check-in, the Commanding Officer was CDR Will Eastham, USN HSC-25 and the Executive Officer was CDR Frank Loforti, USN HSC-25. He conducts maintenance meetings at 0730 and 1930 daily in support of aircraft maintenance and information from the Chain of Command.
- 3. ATCS (b) (6) asked members of the chief mess who could attend the POTUS visit event in the hangar bay. He was told by various members of the ship's chief's mess that there were only 500 personnel from ship's company that could attend. Those personnel have already been identified and were prescreened. ATCS (b) (6) was under the impression that sailors that were not already identified and prescreened could not attend the POTUS visit.
- 4. ATCS (b) (6) instructed his DET to not attend the POTUS Visit during a maintenance meeting prior to the event. ATCS (b) (6) stated that due to attendees being prescreened and work that needed to be accomplished within the DET, that he did not want anyone from the DET to attend the POTUS visit. ATCS (b) (6) specifically told his DET to stay out of the hangar bay.
- 5. ATCS (b) (6) was aware of the POD note, the 5050 and all hands e-mail sent by Staff Judge Advocate, COMPHIBRON 11, CDR (b) (6) , JAGC, USN on 22 May

- 2019. ATCS (b) (6) was aware that the required uniform for attending the event was the Navy Working Uniform (NWU) Type III with eight point cover. He did not brief the DET on these matters because he instructed the DET to not attend the event.
- 7. ATCS (b) (6) was not aware of anyone from the DET wanting to attend the event. He became aware of the aircrewmen attending the event after the event had concluded.

  ATCS (b) (6) confronted the aircrewmen after then even to re-state that he did not want them to attend the event.
- 8. When LCDR (b) (6) USN Officer in Charge (OIC) HSC-25 Detachment Six, became aware of the aircrewmen attending the event and wearing the MAGA patches, he ordered ATCS (b) (6) to muster all nine of the aircrewmen to talk to the LCDR (b) (6) . The crewmen who reported to LCDR (b) (6) stateroom were as follows: AWS1 (b) (6) , USN; AWS1 (b) (6) , USN; AWS2 (b) (6) , USN; AWS2 (b) (6) , USN; AWS2 (b) (6) , USN; , USN; AWS2 (b) (6) AWS2 (b) (6) , USN; AWS3 (b) (6) , USN; and AWS3 (b) (6) , USN. During this meeting, LCDR (b) (6) read DODD 1344.10 to the aircrewmen and instructed them that wearing the MAGA patch during the POTUS visit could be interpreted as a political statement while wearing a uniform. LCDR (b) (6) asked the aircrewmen who told them that they could attend the event. The aircrewmen stated that LT (b) (6), USN HSC-25 Detachment Six, told the aircrewment that they could attend the event. LCDR (b) (6) collected all of the MAGA patches from the aircrewmen with the intent to not return the patches until after the DET returned to Guam.

- 1. PR2 (b) (6) USN HSC-25 Detachment Six was read his UCMJ Article 31b rights. Rights were acknowledged and waived.

- 8. PR2 (b) (6) was not involved with any meetings with the DET chain of command on the day of the POTUS visit concerning the MAGA patch. The first meeting that PR2 attended concerning the MAGA patch was when CDR Frank Loforti, USN HSC-25 Commanding Officer, visited the DET SIX in Okinawa, Japan.







a. Provide fixed security in the Hangar Bay securing all doors, hatches and scuttles leading into the Hangar Bay before, during and shortly after departure of the official party.



## HANGAR BAY LAYOUT





# CO'S MAST RESULTS

#### THIS DAY IN NAVAL HISTORY

1912 - Marine Corps 1st Lt. Alfred A. Cunningham reports to the Naval Academy, where he receives flight instruction, later becoming the first Marine Corps pilot. This date is considered the Birthday of Marine Corps Aviation.

1943 - During the battle to protect British Royal Convoy (ON 184) in the North Atlantic, TBFs from (VC 9) based on board USS Bogue (ACV 9) sink German submarine (U 569) and damage (U 305).

1958 - Marine Corps Maj. Edward N. LeFaivre, pilots an F4D-1 Skyray at NAMTC Point Mugu, Calif., scoring five world records in speed climbs up to 3,000, 6,000, 9,000, 12,000, and 15,000 meters with marks of 44.392, 66.095, 90.025, 111.224, and 156.233 seconds.

1967 - New York City reaches an agreement to purchase the New York Naval Shipyard, also known as the Brooklyn Navy Yard, after it was closed in 1966.

1968 - USS Scorpion (SSN-589) is lost with her crew south-west of the Azores. In late Oct. 1968, her remains are found on the sea floor more than 10,000 feet below the surface by a deep-submergence vehicle towed from USNS Mizar (T-AGOR-11).

1986 - Military Sealift Commands USNS Sgt. William R. Button (T-AK 3012) is christened and launched. The ship serves as one of 17 Container and Roll-on/Roll-off vessels for the Navy and is part of the 36 ships in the Prepositioning Program.



#### CO'S MAST RESULTS

#### THIS DAY IN NAVAL HISTORY

1917 - The first U.S. convoy left Hampton Roads, Va. to cross the North Atlantic after entering World War 1. During the 18 months of war while American vessels escort convoys through the war zone, 183 attacks are made by submarines, 24 submarines are damaged and two are destroyed.

1918 - USS Olympia (C 6) is anchored at Kola Inlet, Murmansk, Russia, to protect refugees during the Russian Revolution.

1939 - Vice Adm. Allan McCann's Rescue Chamber is first used to rescue 33 men from the sunken USS Squalus (SS 192). Four Navy divers receive the Medal of Honor for their heroic actions on May 24-25 to rescue the trapped men.

1945 - Patrol bomber PBM aircraft sink Japanese Special Coast Defense Ship No.21 off the China coast, Task Force 58 attacks airfields on southern Kyushu. In return, the Japanese attack U.S. positions and ships at Okinawa and kamikazes strike USS William C. Cole (DE 641), USS Sims (APD 50), LCS (L) 121.

1961 - USS Gurke (DD 783) notices signals from 12 men from Truk Island who are stranded for three months first at sea and then on an island. USS Southerland (DD 743) investigates the situation and notifies Truk Island, and provides provisions and supplies to repair their outrigger canoe. The men are picked up on June 7 by the motor launch Kaselehlia.

1962 - Aurora 7 (Mercury 7) is launched and piloted by Lt. Cmdr. Malcolm Scott Carpenter. Aurora 7 completes three orbits in 4 hours, 56 minutes at an altitude up to 166.8 statute miles at 17,549 mph.







#### THIS DAY IN NAVAL HISTORY

1813 - During the War of 1812, the frigate Essex, commanded by Capt. David Porter, and her prize, Georgiana, capture the British whalers Atlantic, Greenwich, Catharine (burned), Rose, and Hector (burned) in the Pacific.

1943 - USS Peto (SS 265) sinks Japanese hydrographic-meteorological research ship Tenkai No.2 northeast of Mussau Island. Also on this date, USS Tunny (SS 282) sinks Japanese gunboat Shotoku Maru off the west coast of Rota, Mariana Islands.

1945 - USS Ray (SS 271) sinks Japanese freighter Biko Maru northwest of Changshan. Also on this date, USS Blueback (SS 326) and USS Lamprey (SS 372) damage Japanese submarine chaser Chi in a surface gunnery action off Japara, N.E.I.

1958 - USS Galveston (CLG 3, previously CL 93), the first Talos-firing missile cruiser, is placed in commission. USS Galveston participates in the Vietnam War with the Seventh Fleet and serves in the Mediterranean during the Arab-Israeli War during 1967.

1980 - 55 women become the first female graduates of the U.S. Naval Academy.

2017 - Special Operator 1st Class Remington J. Peters, dies of injuries sustained during an airborne demonstration of the Navy Leap Frogs at Liberty State Park for New York Fleet Week. Peters, a veteran of two combat deployments, was a member of the parachute team for more than a year with more than 900 jumps.




